Minutes for the General Meeting of the Board of Directors August 8th, 2024 - 6:30 p.m. Sunset Beach Woman's Club - 16812 Bayview Drive, Sunset Beach CA 90742

Review and Possible Approval of the July 10th, 2024 Minutes for the General Meeting of the Board and the Annual Board of Equalization Meeting: After Directors and staff reviewed and discussed the July 10th, 2024 General Board Meeting and Annual Board of Equalization Minutes, a motion was made and carried to approve as follows:

MOTION: Secretary Woods moved to approve the July 10th, 2024 General Meeting of the Board and Annual Board of Equalization Minutes as prepared. Director Coultrup seconded, and the motion passed unanimously.

<u>Current Bills:</u> District Clerk Montana presented the August 8th, 2024 Claims Transmitted for Payment for County processing in the amount of \$86,634.63. After Board and Staff reviewed and discussed, Secretary Woods moved to approve the Claims Transmitted for County processing as presented. Director Coultrup seconded, and the motion passed unanimously.

<u>Fund Balance</u>: In Treasurer Hartmann's absence, President Hoad reported the Total Fund Balance as of July 31st, 2024 to be \$3,213,237.

<u>Clerk's Report and Review of Trial Balance:</u> The Clerk reported that the CalRecycle Electronic Annual Report (EAR) had been filed. The current month and final fiscal year-end 2023-24 trial balance was reviewed with the Board and staff.

Review and Possible Adoption of Resolution No. 2024-08-01 to Approve and Adopt the 2024-25 County of Orange Special District Budget, Reserves, and Investment Policies (attached): Clerk Montana presented Resolution No. 2024-08-01 and the Orange County Auditor-Controller 2024-25 Special District Budget in the amount of \$14,438,382, as well as the 2024-25 Reserve and Investment Policies. After review and discussion, a motion was made and carried as follows:
